1. Club Background Information

The Borough of Kirklees (BOK) Swimming Club (known as the Borough of Kirklees Amateur Swimming Club until 1989) was formed in 1982. Key Club facts:

- Swim21 Competitive Level accredited
- 300+ members (swimmers and volunteers)
- Aquatic disciplines:
- Speed (Inclusive of disability)
- Masters
- Synchronised Swimming
- Volunteer Workforce; Managed by a volunteer committee and with over 50 other volunteers supporting Club activities
- Affiliated to the ASA North-East Region and to Yorkshire Swimming Association.
- Funded through Membership fees and general fundraising activities

2. KAL Partnership

BOK works in partnership with Kirklees Active Leisure (KAL) providing the framework for members of the KAL Performance Academy to compete in Speed swimming competitions. BOK is, however, open to all other applicants.

3. Swim21 Accreditation

Swim21 accreditation is the ASA's 'quality mark'. Swim21 is about creating the best possible swimming experience for all, raising the quality of swimming provision across all areas and embedding the Safeguarding of young swimmers at the heart of all Club activities.

It ensures that the club focus specifically on the needs of athletes, providing them with the best possible support and environment and requires the annual provision of key evidence to a national panel to demonstrate on-going quality.

The accreditation allows the club to access funding to support workforce development and training camps.

Swim21 has a strong focus on partnership work, requiring the Club to develop and maintain networks with other clubs, schools and organisations such as Kirklees Active Leisure and Kirklees Council.

4. Safeguarding

BOK adheres to 'Wavepower', British Swimming's safeguarding guidance, which has useful information for all Members and parents of swimmers. The latest version of this documentation can be found at:

The Club Committee appoint a Welfare Officer who is responsible for all Club safeguarding matters.

5. Volunteers

The club is totally reliant on the support of its members i.e. the parents, to administer the club, which includes entering swimmers for galas, organising our own galas and general fund-raising. Parents are urged to get involved and assist in any way possible, however small. It is important that

volunteers are shown respect and appreciated by other club members. There are various benefits associated with on-going volunteering for BOK and KAL.

ASA Membership

For swimmers to be able to take part in competitive swimming, they must be members of a Swimming Club affiliated to the Amateur Swimming Association. The Borough of Kirklees SC offers this facility for its Members.

7. Communication

8. Payment of Bills/Fees

The Club expects bills to be settled on time. If a debt is left unpaid for more than 2 months action may be taken which could result in membership being suspended.

Where genuine financial hardship is an issue, the club will consider offering a subsidy on the club fees or for gala entries. Requests will be discussed on a case by case basis, in line with section 4.5 of our constitution. Information on the criteria can be obtained from the club Secretary.

9. Competition Guide & Calendar

The Club provide a Guide to Competitive swimming and publish a rolling annual Competition Calendar, compiled by the KAL / Club Coaches. This adheres to the principles of Long Term Athlete Development. Individual entries as a BOK swimmer to competitions other than those on the Club Calendar are not permitted without Head Coach approval.

10. Club Awards

The club presents the following annual outstanding swimmer awards:

Female: 9 - 13 years, 14 + years

Male: 9 - 14 years, 15 + years

Most improved swimmers of the year (the Shirley Beever award)

The awards are based on age at the end of the year and on performances at county, regional (LC), and if eligible, national level or equivalent. Representative honours are important and club records may well be taken into account.
